For those already attending a school, a copy of your <u>unofficial</u> transcripts showing you were enrolled last semester will suffice. (<u>School must be located in the State of Alabama unless the courses needed are not offered in Alabama. Special considerations are given to Nurse, <u>Medical, Veterinary, and Pharmacy majors who are competing for limited slots in Alabama schools.
